<u>Treasurer's Update</u>

- £10 minimum top up on clubhouse or competition purses on members' cards
- Debit card or cash transactions for sales any amount

Doreen informed the board that both men's Open tournaments are filling up quickly. The first tournament, the Spring Mixed Greensomes, is only 38% full at present. We will keep monitoring the situation and may have to reduce tee times.

We need to set up a sub-committee for tournaments. Lynn Coull is the only member who has offered to help Doreen to date. Graham is to ask for help at the AGM and Doreen will send out an email after that.

<u>MGLL</u>

Brian gave an update from MGLL. 2022/23 budget costs are up by 35% on last year, predominantly due to fuel, fertilizers and salary related costs. There is an ongoing exercise to simplify all aspects of the business e.g. reducing Season Ticket Holder categories.

All revenue streams are being looked at - Season Ticket Holders, Visitors and buggies. Four new electric buggies have been purchased. Approval from Angus Council is still outstanding for the new on-course toilets. Although the toilet block is being donated, utilities will cost in excess of £10,000.

Graham requested that one of our club representatives attend part of each monthly RMMGC board meeting, details to be agreed.

Brian L would like regular updates on the progress of our club development plans as this will affect the whole visitor experience at Montrose Golf Links.

Brian Leask was asked to discuss the Montrose Open Tournament with Gavin Hemsley to establish whether Gavin needs to proceed with his invitational tournament the week prior to the proposed MGLL open tournament – this had been brought up by a number of our members who were actually sponsoring Gavin's tournament but would be happy to move
