#### Welcome

PW welcomed everyone to the meeting and took the opportunity to present JP with an engraved crystal decanter in recognition of his contribution to the Board and leadership as Club Captain.

#### **Prize Draw**

The Annual Prize Draw was held at the AGM on 5<sup>th</sup> February. As such, there is no February monthly prize draw.

## **Review of Action Point Register**

The APR was reviewed and updated.

PW suggested that the revised Members Welcome Packs be distributed to new members from the 2024/25 season, as well as those joining in preparation for the new season. This was agreed.

SL advised that the fees displayed on the Club website need to be updated to reflect the 2025/2026 season. DL to forward new fees to Mike Cummins for uploading.

### Q & A on Submitted Reports

#### Secretary's Report

The Board agreed that there is no need for Bar and Catering figures to form part of the Secretary's Report since these figures are already included the Treasurer's Report. Going forward, the Club Secretary/Membership and Marketing Director's report will focus on these two elements, i.e. membership and marketing!

PW asked for a report to be produced indicating average spend on bar and catering among Associate members compared to golfing members.

## Treasurer's Report

Overall, our financial position remains on a sound footing. A meeting will be arranged between PW, RS and DL, the focus of which will be to budget for forthcoming salary/wage increases.

DL advised that a 'blanket increase' to bar prices is impractical since the cost of some items has increased more than others. A notice advising members of forthcoming bar price increases will be issued mid March.
